ARC REPORT presented by Nestor Paul Oppegard

Requests for: 2 solar panels, 1 roof modification increasing slope, 1 garage remodel, 5 landscaping requests, 1 fence.

All were approved.

Group discussion regarding new construction at 9150 E. Radcliff Ave.:

T.J. spoke with Arianne Gronowski on August 18th concerning criteria to be used by the ARC when approving/denying submissions. Our current covenants and bylaws do give the board the right to deny homeowner requests for structural changes. T.J. explained the circumstances and concerns of allowing a two story home in a section of the neighborhood which only has 1 story homes. Ms. Gronowski suggested that we have to look at the existence of two story homes anywhere in the neighborhood. Our covenants and bylaws do not differentiate any blocks or sections of the neighborhood. T.J. let her know that we have multiple two story homes mixed throughout the community. Ms. Gronowski's opinion was that if the HOA Board rejected the proposal, based on the home being two stories and larger than the current home, and the homeowner chose to fight the decision, the HOA would not be successful. The Board continued to discuss many scenarios regarding this project and decided to not ask the ARC members to deny it. Paul said they would continue to have discussions with the homeowner and ask if they could possibly tone down the starkness and contrast of the color schemes, helping the home blend in better with the neighborhood.

CRC REPORT

Larry handled complaints of weeds, and dead tree branches. He will be speaking to a neighbor about exposed trash cans later this week.

Larry said we have received a complaint about a neighbor dog sitting multiple dogs acting like a kennel, he will also look into this.
